

We will be utilizing the AGILITY GATE APP for convenient check-in and gate management.

Agility Gate is a free-to-download app that allows competitors to check-in their dogs via their mobile phone or tablet at an agility show and keep track of the current state of the run orders. It helps prevent crowding around the gate and allows competitors to keep tabs on things while crating away from the ring or away from the show site.

The access code is 1010.

Course maps will be posted at the trial site. You can take a picture of the posted maps or download a copy to your phone using the Agility Gate app. Paper copies of the maps will not be available.

Arrival/Setup

You may begin setting up at 6:30 a.m. on Saturday and Sunday.

DOGS MAY NOT BE LEFT AT THE SHOW SITE OVERNIGHT.

We will unload the trailer at 1 p.m. on Friday afternoon. If anyone would like to help, it would be greatly appreciated. People who help unload the trailer on Friday will be able to set up then, PLUS you'll get Worker Coupons!

YOU WILL ONLY BE ALLOWED TO SET UP ON FRIDAY IF YOU HELP UNLOAD THE TRAILER. THANK YOU!

Measuring

All agility dogs are required to have an Official Jump Height Card and must be able to present it if asked. Don't forget to bring your height card in case someone asks for it.

Our judge is a VMO (measuring official). ALL dogs (regardless of height) without a valid Jump Height Card or Yellow "Temporary Measurement" Form (for dogs under 2 years old) must be measured before their first run of the weekend. Forms will be available at the ribbon-label table. Please fill out a form before asking to be measured. If you already have a permanent height card, be sure to have it with you at the trial in case you are asked for it. If your dog needs to be measured, it is your responsibility to have it done before you run. Failure to do so will result in the removal of any qualifying runs you receive.

Check-In (Armbands Not Required)

Pursuant to Chapter 1, Section 19 of the Regulations for Agility Trials (Revised July 2016), the club will not be requiring the use of armband stickers, so traditional checkin is not required.

No paper check-in will be required. We will be using the **Agility Gate App** for check-in from your phone ... see left sidebar for more information.

Running orders

A running order will be posted on <u>imagilityservices.com</u> 3-4 days prior to the first day of the trial.

Concessions ...

There will be no concessions at the trial. Please feel free to bring your own lunch, snacks and drinks. Fast food is convenient to the show site as well.

Course Maps

Course maps will be posted at the trial site per AKC Agility Regulations. Please take a picture of the posted maps for access on your phone or tablet. Maps will also be posted on the Agility Gate App.


PLEASE REMEMBER ...

Exhibitors are responsible for cleaning up after their dogs immediately on hotel/motel and show grounds. Motels/hotels require that dogs be crated when unattended; no bathing or grooming of dogs in guest rooms. Exhibitors/handlers are responsible for any damage to motels/hotels or the event site and may result in disciplinary action by the Event Committee. Entries may be refused in the future for previous misuse of the motel or show facilities. This is an AKC-supported measure.

The Trial Site

The town of McKinney is about 33 miles north of downtown Dallas on U.S. 75/North Central Expressway. From the north or south: On U.S. 75, take the U.S. 380 exit and go west about 2.5 miles to FM1461. Turn right (north) on FM1461 and travel approximately 2.9 miles to County Road 166. Turn right (north) on County Road 166 and go 0.8 (8/10) mile to the site which is on the left. The county has posted directional signs to the Event Center.
