Agility Gate is a free-to-download app that allows competitors to check-in their dogs via their mobile phone or tablet at an agility show and keep track of the current state of the run orders. It helps prevent crowding around the gate and allows competitors to keep tabs on things while crating away from the ring or away from the show site.

Arrival/Setup

You may begin setting up at 6:30 AM all three days. We will start unloading the trailer at 6:30 AM Friday morning. **If anyone would like to help, it would be greatly appreciated. You'll get to set up a little early PLUS you'll get Worker Coupons!**

Measuring

All agility dogs are required to have an Official Jump Height Card and must be able to present it if asked. Don't forget to bring your height card in case someone asks for it.

A Volunteer Measuring Official (VMO) will NOT be at this trial, so there will no official measurements. If you do NOT have a permanent height card you will still need get an unofficial measurement to ensure you are in the correct jump height for this weekend.

All exhibitors who do not have a permanent height card or temporary (yellow) measurement form must be measured **BEFORE** running (unless you're jumping 24"). Measurements will be taken all day between classes. It is the exhibitor's responsibility to have their dog measured prior to running.

Check-In (Armbands Not Required)

Pursuant to Chapter 1, Section 19 of the Regulations for Agility Trials (Revised July 2016), the club will not be requiring the use of armband stickers, so traditional check-in is not required. We will be using the **Agility Gate App** for check-in from your phone ... see left sidebar for more information.

Concessions

Java Journey coffee truck will be on site all three days. You may bring in food from outside and there are lots of restaurants nearby.

Running orders and Course Maps

A running order will be posted on imagilityservices.com 3-4 days prior to the first day of the trial.

Course maps will be posted at the trial site per AKC Agility Regulations. Please take a picture of the posted maps for access on your phone or tablet. Maps will also be posted on the Agility Gate App.

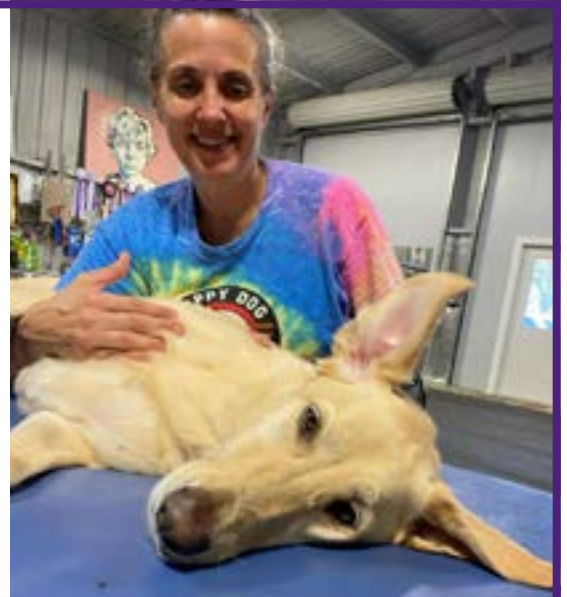

The Trial Site

The town of McKinney is about 33 miles north of downtown Dallas on U.S. 75/North Central Expressway. From the north or south: On U.S. 75, take the U.S. 380 exit and go west about 2.5 miles to FM1461. Turn right (north) on FM1461 and travel approximately 2.9 miles to County Road 166. Turn right (north) on County Road 166 and go 0.8 (8/10) mile to the site which is on the left. The county has posted directional signs to the Event Center.
